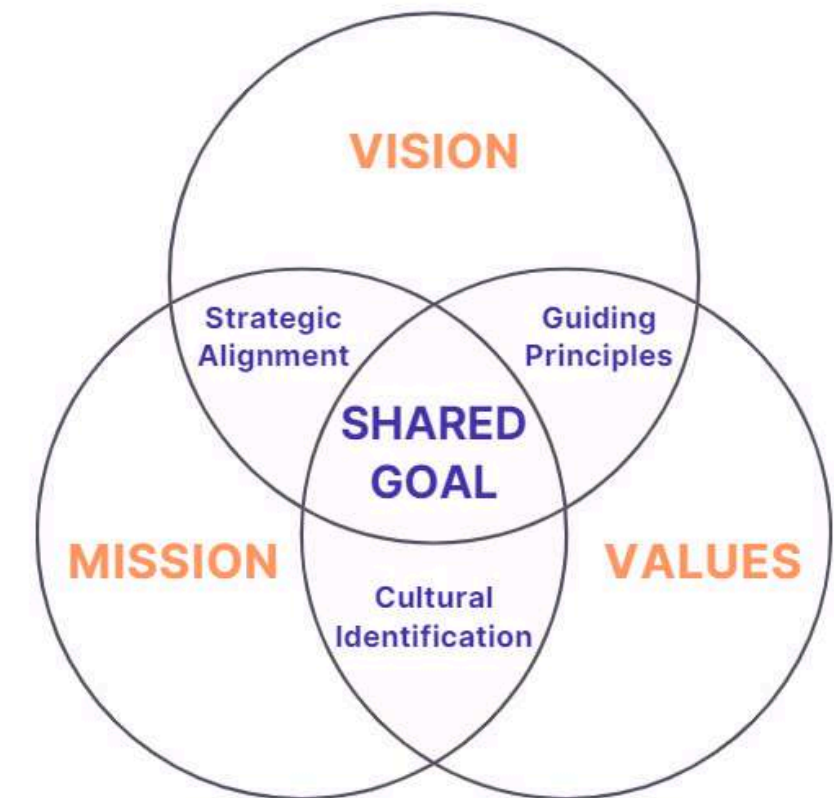

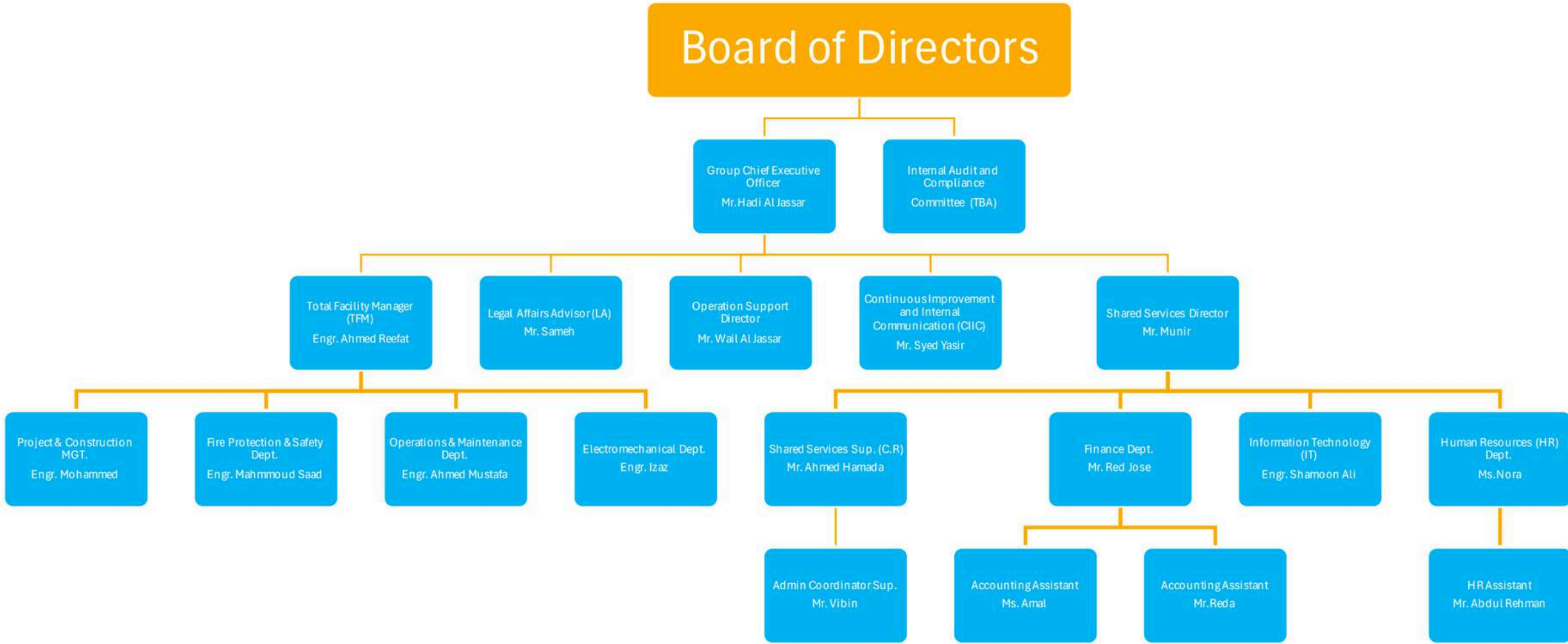

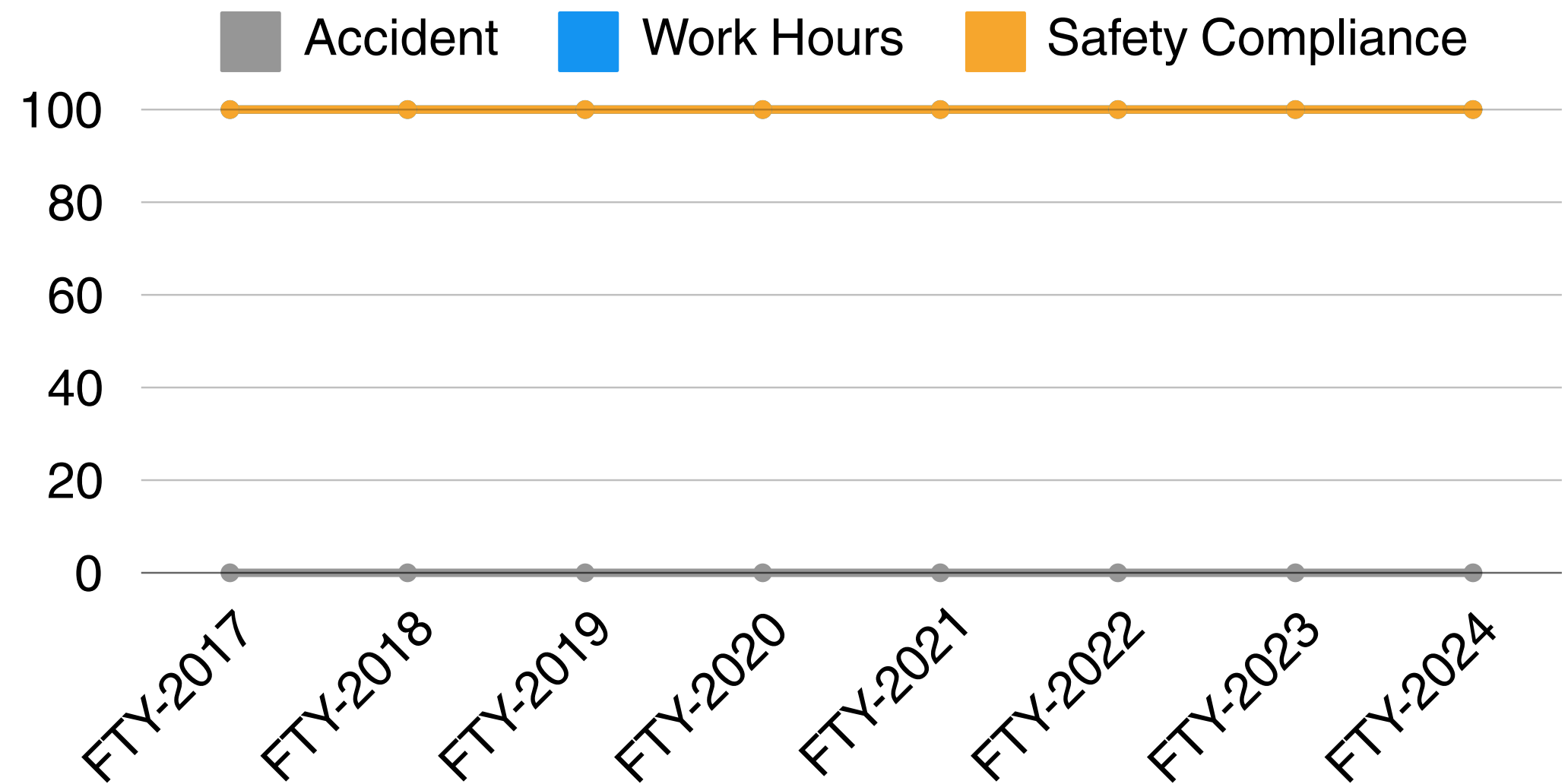




A Zero Accident Vision (ZAV)

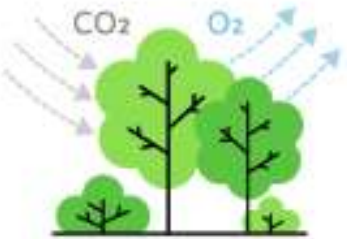
AJCO recognizes the responsibilities placed on it by the relevant environmental legislation and regulations on the nature, scale, and environmental impacts of its activities, products, and services.

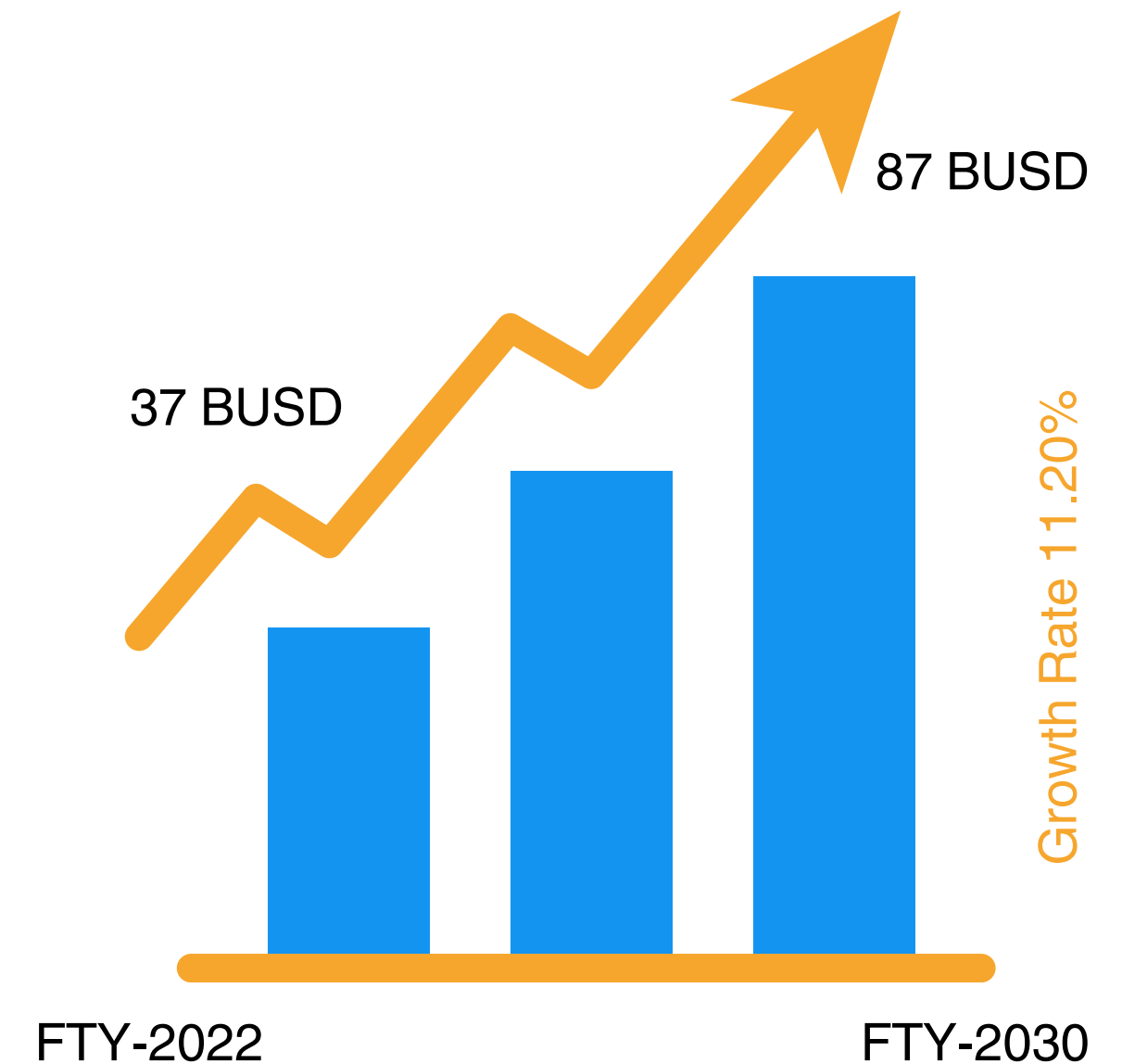


Strategic Growth Plan

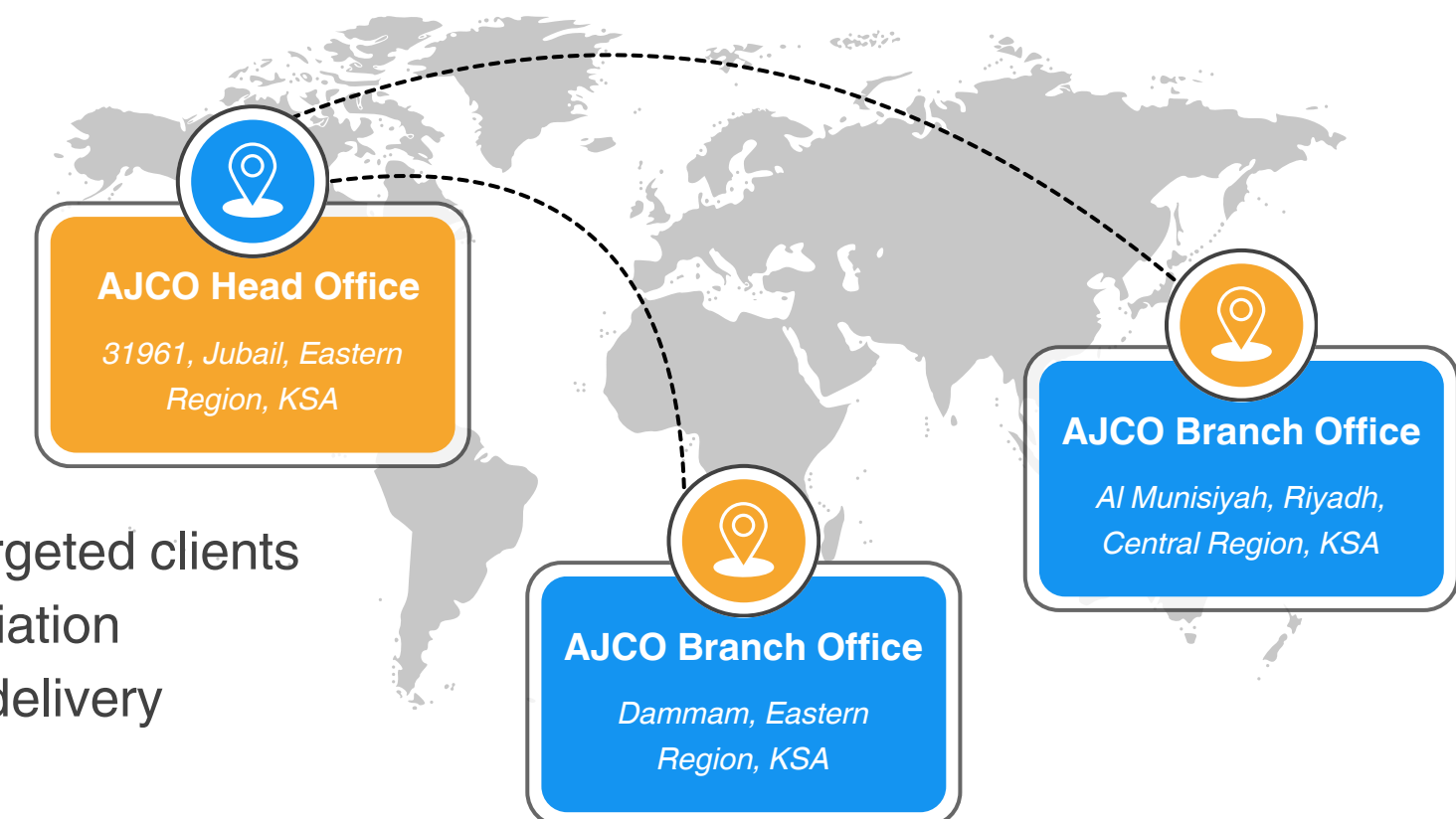


Growth Ambition

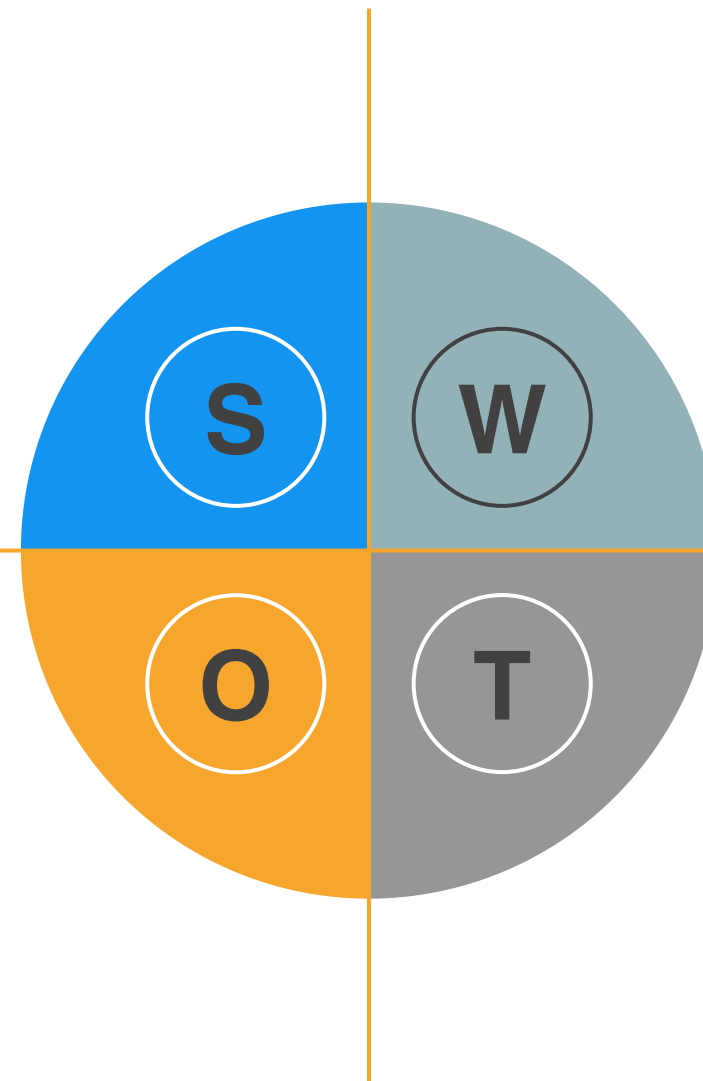

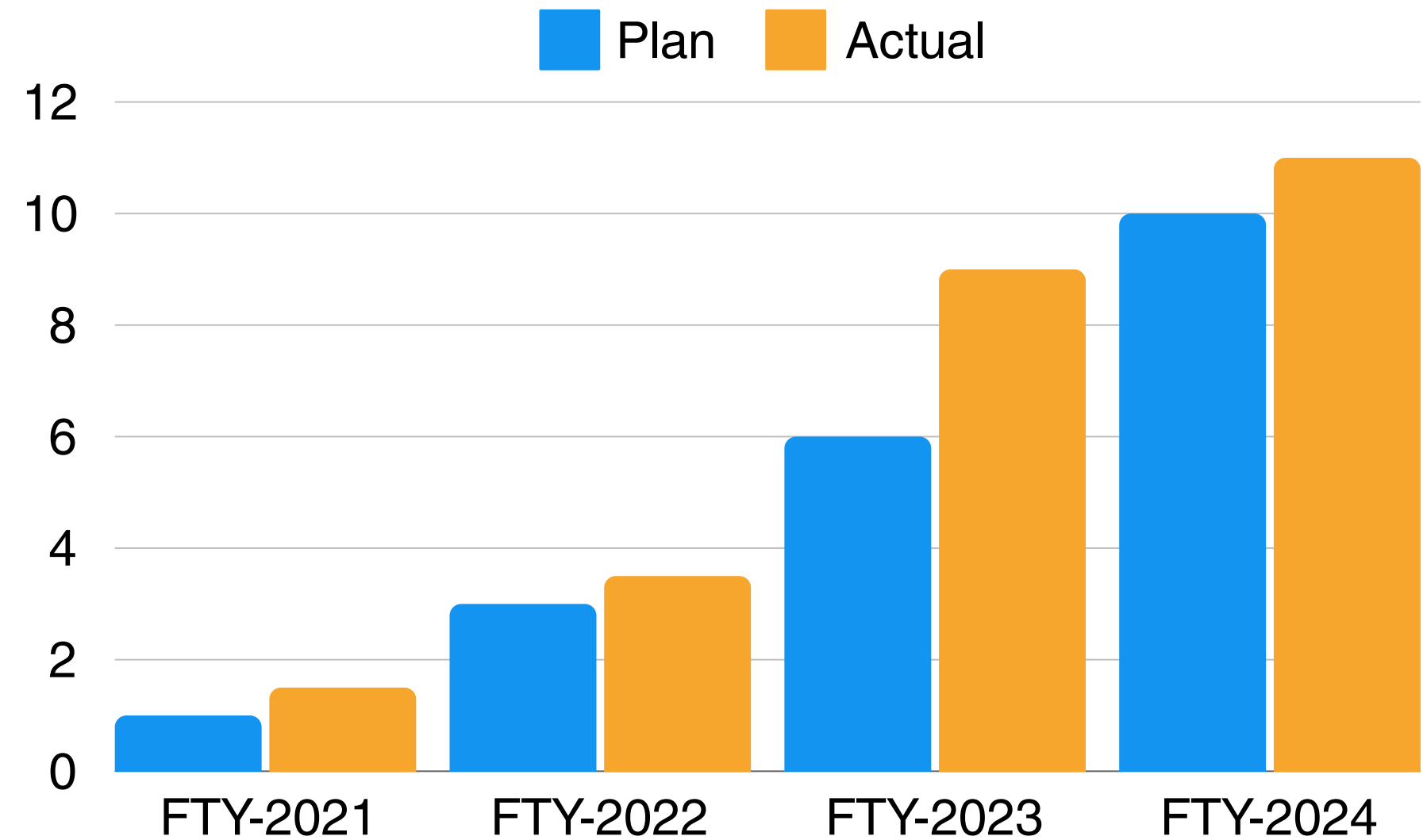
